

## Service Officer VETERAN'S ISSUES

While working at the latest Post blood drive, I mentioned to a couple of our Post members what a fine program "My HealtheVet" is. Neither of the members had ever heard of it. The program is designed to give our Veterans who are enrolled in the VA Health care system access to their entire VA medical records. Here are some of the things available with a premium account:



- VA Admissions and Discharges (including discharge summaries) Discharge Summaries are available 3 calendar days after they are completed.
- VA Allergies
- VA Appointments (future)
- VA Appointments (limited to past 2 years)
- VA Demographics
- VA Electrocardiogram (EKG)
- VA Immunizations
- VA Laboratory Results: Chemistry/Hematology/Microbiology VA Laboratory Results are available 3 calendar days after they have been verified. Depending on the type of test, some laboratory results may not be available right away.
- VA Medication History
- VA Notes VA Notes written from January 1, 2013 forward are available 3 calendar days after they have been completed and signed by all required members of your VA health care team.
- VA Pathology Report: Surgical Pathology/Cytology/Electron Microscopy. VA Pathology Reports are available 14 calendar
  days after they have been completed. Some studies done at a non-VA facility may not be available or they may not
  necessarily include an interpretation.
- VA Problem List Your VA Problem List contains active health problems your VA providers are helping you to manage. This
  information is available 3 calendar days after it has been entered. It may not contain active problems managed by non-VA
  health care providers.
- VA Radiology Your report is available 3 calendar days after it has been verified by members of the VA health care team
- VA Vitals and Readings
- VA Wellness Reminders
- VA electronic health record information such as VA Continuity of Care Document (VA CCD) and other information as it becomes available
- Department of Defense (DoD) Military Service Information

Attached is a link you can open to start your account with simple directions to walk you through the required steps. With "My HealtheVet" you can schedule appointments, have a secure message with your doctor or nurse, order your prescriptions and just about anything else you might need from the VA. ## Service Officer VETERAN'S ISSUES (Continued)

### **Congressional Budget Hearings**

The Congressional Budget options, if accepted, will have very serious consequences for our Post Veterans and Military Retirees. Our Post Veterans who receive compensation for Un-employability will have that benefit stripped from them upon reaching age 70. Our Post members who are Military Retirees will have to pay \$970. Per family per year for Tri-Care for Life coverage and have a co-pay for all services. At present this is totally free and a benefit that all Retirees were promised when they enlisted if they stayed for 20 or more years. Please e-mail your Congressmen and Senators if you wish to keep your benefits. Little by little Congress will strip away all of your earned Military Retirement benefits unless you make yourselves heard. Contact your representatives today!

The Congressional Budget Office (CBO) has recently published an annual report: Options for Reducing the Federal Deficit: 2019-2028. This report is an extensive list of possible options for Congress to consider for reducing the budget deficit. They are not legislative proposals but rather recommendations. However, concern about the growing annual spending deficit for the current fiscal year (currently estimated at \$984 billion) is increasing in Congress and these recommendations could be considered to help reduce the deficit. Some of the many recommendations in the report include:

A new TRICARE-For-Life (TFL) annual enrollment fee of \$485 for individual coverage and \$970 for family coverage, and increased cost-shares;

Increasing TRICARE Prime enrollment fees to \$650 for individual and \$1300 for family;

Increasing TRICARE Select annual enrollment fee to \$485 for individuals and \$970 for a family;

Reduce active duty BAH to 80 percent of actual cost;

Limit active duty annual pay increases; and

Eliminate VA's Individual Un-employability payments to disabled veterans at the full retirement age for Social Security.

#### FREE LEGAL ADVICE FOR VETERANS

Coming up in the first quarter are free legal clinics for Veterans. These clinics provide lawyers to answer legal questions you may have about wills, trusts, health care directives, power of attorney, housing employment, debt collection, expungement, child support and family law. These services are totally free and you don't need an appointment, just walk in. I can't stress enough the importance of your spouse and yourself having valid "power of attorney" documents on each other. In case of sickness or death these documents will save you numerous headaches and heartaches.

The Legal Clinic in Anoka is: March 12, 2019 room 237 at the Anoka county court house from 9 – 2pm

The legal clinics at the Minneapolis VA medical center are:

February 5, 2019 from 9 - 2pm in the flag atrium March 7, 2019 from 9 - 2pm in the flag atrium

Just bring a copy of your DD-214 to show proof that you are a Veteran and have your questions ready for the Legal Team.

The red poppy has connected generations of veterans, service members and their families with civilians in remembering all those who have fallen. And for more than 75 years, the VFW's "Buddy"® Poppy program has honored those who have sacrificed by raising millions of dollars to support veterans' well-being.

Remember that a portion of the proceeds for Buddy Poppies goes to support the National Home for Children.

The VFW National Home for Children was founded in 1925 in Eaton Rapids, Michigan as a place where families left behind by war could remain together, keeping the family circle intact even when their serviceman didn't come home.

Today's military and veteran families face different challenges -- reintegration, post-traumatic stress, high unemployment and rehabilitation from battlefield injuries, among others -- and the National Home has evolved over our decades-long history to meet those changing needs.

In addition, we understand that the impacts of war can be generational. The National Home is here to help veteran connected families as well who are directly related to a VFW or Auxiliary member or are eligible to become one.

Resident families can accomplish significant life goals by participating in our program. We offer case management services to help families establish their plans for the future and set goals, education, recreational, and enrichment opportunities for parents and their children, as well as free housing and daycare. Community resources and counseling provided as needed.

Greetings Palmer Lake Comrades, Friends, and Family!

The 2019 "Minnesota Veterans Day on the Hill" is scheduled for Wednesday, 20 March 2019! The event is an opportunity for Veterans, family members, and advocates to hear from and speak with Minnesota law makers regarding legislation affecting Minnesota Veterans and their beneficiaries. VFW membership numbers count on paper, but an in person rally in the state rotunda full of VFW members, Veterans, and supporters can be striking to lawmakers!

The Minnesota Association of County Veteran Service Officers (MACVSO), the Minnesota Commander's Task Force, and the United Veterans Legislative Council of Minnesota are sponsoring the event. The agenda is not set, however tentative plans call for a luncheon at 11:30 followed by a rally at 13:30 in the capitol rotunda. Last year's event also included small group issue oriented break-out sessions with local lawmakers — hopefully this will be included this year as well. I'll provide more information as details unfold to include legislative topics and possible transportation options to and from the event. 





## At 108 and 105, cribbage players battle for title

"What's going on today, we're having a cribbage tournament between two of our oldest residents in Presbyterian Homes," explains Rob Lahammer, who arranged for Don to travel from his apartment at SummerWood of Chanhassen to Waverly Gardens. "When Harry met Don, a game for the ages," says Rob, repeating the title that tops the posters pinned to the bulletin boards publicizing the event.

"He's been playing cribbage probably most of his life," Bob Carruth says about his dad. "He loves the game, played with my mom forever."

Harry has thrown down the gauntlet. "It's going to be a pretty good person that beats me," he said earlier in the day. "So, we're going to find out today."

Rob introduces the players who've been fitted with white and green jerseys, their respective ages – 105 and 108 – displayed in large numbers on their backs. Microphone in hand, Rob informs the crowd both Harry and Don were alive when women gained the right to vote - and were of drinking age during prohibition. "Just tell me to stop," he tells Don, "if you get annoyed with me talking too much." At 105, Don doesn't miss a beat. "Stop," he says. The crowd erupts in laughter.

For the next 30 minutes the 105-year-old retired principal and the 108-year-old retired forester engage in an intense back-and-forth. "Oh, it's serious, cribbage is serious for my dad," Bob Carruth says. "Go dad!" he cheers. Myrna Camp nervously watches her husband take an early lead, then surrender it. After several hands, one point separates the players.

"This is crazy," Rob Lahammer announces to the crowd. "Harry Camp is four pegs away, Don Curruth is three pegs away." Myrna puts her face in her hands as the tension builds. Then, the young upstart makes his last move.

Game over.

By one point, 105-year-old Don has defeated 108-year-old Harry.

The crowd cheers and Don and Harry shake hands. For Don, there will be no savoring the victory. He takes a bow and grabs hold of his walker. "Just another game," Don says and heads for the door. Don's son smiles. "When it's over, it's over for dad. He's moved on already," Bob Carruth says. "Probably why he's lived to 105."

Harry lingers, remaining onstage at the table as he accepts congratulations for a game well played. "The best man won," he says. "But next time I'll get him."

At 108 Harry Camp is still game.





#### BUDGET

- ✓ Preserve the integrity of TRICARE.
- ✓ Modernize VA and DOD health IT systems.
- Strengthen health care and research for mental health and traumatic brain injuries (TBI).
- ✓ Expand gender-specific programs and competencies.
- Research and effectively treat health conditions associated with toxic exposures.
- Prevent the increase of pharmaceutical copayments and remove copayment requirements for preventative medicines.
- ✓ Research the efficacy of medical cannabis.
- Expand telehealth services.
- Make nursing home eligibility part of the VA health benefits package.
- ✓ Keep community care reimbursement rates competitive with private health insurance.

- Properly implement the modernized appeals process.

- ✓ Small business development opportunities.
- Civilian credentials or academic credit for military training
- Hiring preferences in the civil service and with large government contractors.
- ✓ National veterans treatment court advocates.
- ✓ Education and training in new and expanding career fields.
- Timely and improved transition assistance including access to programs for veterans after they leave military service.

- Affordable housing and wraparound services to avoid homelessness.
- Equitable education benefits for dependents regardless of where they live.
- Improved character of discharge review and appeals procedures.

#### MILITARY QUALITY OF LIFE

To maintain a quality, comprehensive benefits and retirement package that is the backbone for an all-volunteer force, Congress and DOD must:

- Increase military base pay comparability with private sector wages.
- Ensure that military housing is safe and free of toxic substances
- End the military retirement pay and VA disability compensation offset.
- Eliminate the Survivor Benefit Plan/Dependency and Indemnity Compensation offset.
- ✓ Increase the government's Thrift Savings Plan contribution
- Eliminate sexual assaults in the military.
- ✓ Establish the Armed Forces University.
- Improve stability and support for military families.

#### NATIONAL SECURITY, FOREIGN AFFAIRS & POW/MIA

To fully support U.S. troops and their mission to fight the war on terrorism and protect our nation's citizens and interests around the world, Congress, DOD and DHS must:

- Expand partnerships with host nations and private/public organizations to achieve the fullest possible accounting of U.S. military personnel missing from all wars.
- ✓ Secure America's borders.
- ✓ Preserve the all-volunteer force.
- ✓ Maintain a substantial military presence in the Republic of Korea.
